## FROM THE DESK OF MAYOR THOMAS FERRUCCI



Four months have elapsed since the spring edition of the Sloan Connection was published. We have completed the storm sewer replacement. curb installation. milling and paving of Celina and Mann Streets. Wrazen Parkway has been milled and paved, and Griffith will be completed after a minor sanitary repair near Broadway. Our multi-year repair/replacement of sanitary project has been delayed all summer, pending Public Works and Concrete contract approvals by the Environmental Facility Corporation (EFC). The EFC is the funding agency for our WQIP and WI-IA grants, and the contracts ratified by the Village Board five months ago have been pending EFC approval since. However, televising and over 11,000 feet of slip lining has been completed where possible. Slip lining or CIPP can be undertaken only where pipes are not out of alignment or completely disintegrated, which would necessitate a spot repair/or reconstruction. With the impact of COVID on material costs, shortage of products and labor, what was originally estimated to be a three year project will likely extend an additional few years. We ask our residents for their patience and understanding while the Village is forced to contend with these delays that are beyond our control.

The Village has been contacted by the School District, requesting the lowering of the speed limit around Woodrow Wilson from 30mph to 20mph for the safety of students. We have received numerous complaints of speeding and reckless driving in the area, and should be approving a resolution at our October 11th meeting. Please be aware of this impending change in speed limit on both Reiman and Halstead in the close vicinity of the school. We will request the Cheektowaga Police to increase enforcement in

the area, especially during student drop off and pickup times.

In September, the Village facilitated the demolition of 2123 Broadway Street, a vacant structure that had fallen into severe disrepair and was in imminent danger of collapse. It was condemned by our Code Enforcement Officer, who subsequently ordered its removal. During demolition, the contractor discovered possible ground contamination and the presence of two underground holding tanks. We immediately contacted the DEC, who have opened a formal investigation. As Mayor and lifelong Villager, it is my commitment to our citizens that we pursue any action needed on vacant properties to ensure residents safety, protect our neighborhoods and preserve our quality of life.

# FROM VINCE FERRARACCIO, CODE ENFORCEMENT OFFICER

Title 1203 of the 19 NYCRR, mandates each municipality in New York State to inspect all residential properties that are more than two family for health and safety every three years. This past summer, my office mailed notices to owners of approximately one-third of multiple dwellings in the Village of Sloan advising of this requirement. Response has been lower than expected; if you have received a letter and have not submitted the application yet,

please do so and we can schedule an appointment. Once the property is in compliance, a subsequent inspection will not have to be completed for three more years.

In the past two years, I have referred thirty cases to the Town of Cheektowaga Housing Court for enforcement. Court cases are the final step afforded to a Code Enforcement Officer and only after several Notices of Violation or Orders to Remedy have been sent

to the property owner. Should you receive such notification, please correct all violations in a timely manner and contact my office to review.

The condition and maintenance of structures plays a vital role in the success and preservation of our Village community. Our goal is code compliance, preserving property values and maintaining quality neighborhoods.

## FROM ALAN WIEBERG, FIRE CHIEF

October is Fire Prevention Month. We would like to remind our residents the importance of having functional smoke alarms in every bedroom, outside of each sleeping area and on every level of the home, including the basement. CO detectors are required on every level where there is a fuel burning appliance and every sleeping level. Please be sure to check all batteries in your detectors and replace any smoke or CO detectors that are more than 10 years old. Smoke and CO detectors do save livesbut only if they work properly!!

It has been one year since we contracted for the purchase of a new fire engine to replace our 2003 American Lafrance Rescue Pumper. The new truck is in production and should be delivered in December. It will be a "twin" vehicle to our 2018 Rosenbauer Engine. Having apparatus with comparable designs will reduce the training period for our members as they will drive and operate exactly the same.

In recent weeks, we have hosted drills with eight fire companies from Cheektowaga, Depew and Hamburg, focusing on vehicle extrication and fires. Several buses were donated by the owner of 2060 Auto Parts, Mike Serwacki. who allowed us use of his property for the drills. Collaboration and training with other departments better prepares us for any mass disasters. Recent drills provided an excellent opportunity to practice with our new extrication equipment, recently purchased through a grant provided by Assemblywoman Wallace. ## FROM ERIC CZUBAJ, DEPUTY MAYOR & RECREATION DIRECTOR

While writing this article, the Griffith Park Sports Court project is finally underway after contractor delays. New storm drainage is being installed prior to paving and fence replacement. The project was funded primarily through \$80,000 grant received from Assemblywoman Monica Wallace and will include concrete sidewalks between the parking lots on Griffith and the ADA accessible park equipment, new picnic tables and more. Additional grant money from County Legislator Tim Meyers will be used towards sun shelters and seating in the Splash Pad area. Our goal in the next two years is to obtain a grant to update the bathrooms in Griffith Park to provide ADA accessibility. The park building has

seen few upgrades since constructed in the 1960s and the addition of the new park shelter in 2020 has greatly increased our summer rental requests.

This past summer, the Splash Pad and Griffith Park were enjoyed by so many of our community children and families. Michele Kramarsyck, our Recreation Supervisor, with the help of our Free Library librarian, Mary Maly, led a new Summer Reading Program. At our October 11th meeting, high reader awards were presented to Kaylee Conklin, Matthew Ernst, Chloe Huffman and Evannie Diazwho all received gift cards generously donated by Target. Congratulations to all participants! The lunch program served 1,451 free meals to our youth in a six-week period; a huge thank you to the Cheektowaga Sloan School District for providing this service! The Sloan Arts Council celebrated their 20th year of sponsoring the Summer Concert Series. This organization is staffed by a dedicated group of volunteers who I am proud to be a part of since becoming Deputy Mayor four years ago.

Our Youth and Recreation Center is scheduled to open on November 4th. We have relocated it from upstairs to down at the Community Center on Halstead. This will provide a safer environment for our children and improved use of our facility. Check the Village Recreation Facebook page or website for more info on hours and programs.

## HOLIDAY SCHEDULES, SEASONAL REMINDERS & MORE...

Overnight parking ban is effective November 15th until April 1st. There is no parking on Village streets from 2:00am-7:00am to allow for plowing and salting. Overnight parking is available in municipal lots: Griffith Park near the tennis courts, Village Hall and the Fire Hall. Stop by Village Hall to obtain your free parking pass.

Hiring a snow plow contractor this winter? A Snow Plowing Permit MUST be applied for by your contractor. They must submit a current copy of their NYS Drivers License, Vehicle Registration and Insurance. These documents are required to protect you, our residents, from theft of services and/or damages. The cost is only \$25.00 per license.



Village Trick-or-Treating will be on Monday, October 31st. The fun begins at 6:00 pm in front of St. Andrews's Church. The Fire Department will lead a parade of little ghosts, goblins and princesses to the Community Center at 140 Halstead Avenue! Distribution of goodies will be to all in costume then neighborhood trick-or-treating until 8:00pm. Be safe- carry a flashlight, apply reflective tape to costumes and if driving, watch for families and children crossing the streets!!!

#### **OUTDOOR FIRE PIT SAFETY**

Fire pits must be on a level surface at least 15 feet away from any structure and a safe distance from any low-hanging branches, wood piles or combustible material. You must have a fire pit cover, fire extinguisher and/or garden hose nearby for use if necessary. ONLY clean wood can be burned—no trash or painted/treated wood! If the smoke creates a nuisance for your neighbors, you will have to cease burning.
