2020-29 Senior Property Tax Exemption

WHEREAS, Real Property Tax Law Section 497(3) permits a municipality corporation to adopt an income limitation on the partial exemption from taxation for certain owners of property who are sixty-five years of age or older; and

WHEREAS, the Code of the Village of Sloan, Chapter 407, Article II, Section 16 (A) currently prohibits the exemption to those otherwise qualified property owners whose income for the income tax year immediately preceding the date of application exceeds twelve-thousand, five-hundred dollars (\$12,500); and

WHEREAS, this Board wishes to increase the income limitation on such exemption to nineteenthousand, eight-hundred dollars (\$19,800); Now, Therefore Be It

RESOLVED, that the Code of the Village of Sloan, Chapter 407, Article II, Section 16 (A) shall be and is hereby amended by deleting the words "twelve-thousand, five-hundred dollars

(\$12,500)" and inserting the words "nineteen-thousand, eight-hundred dollars (\$19,800)" in their stead.
